I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING THE ORGANIZER AND PROMOTING ORGANIZATIONS, THE SPONSORS OF THIS EVENT, PROPERTY OWNERS, LAW ENFORCEMENT AGENCIES, ALL PUBLIC ENTITIES, SPECIAL DISTRICTS AND PROPERTIES, AND THEIR RESPECTIVE AFFILIATES, AGENTS, OFFICIALS, AND EMPLOYEES THROUGH OR BY WHICH THE EVENT WILL BE HELD (COLLECTIVELY "RELEASEES") FROM LIABILITY. THIS RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES. I HAVE BEEN ADVISED TO READ IT CAREFULLY BEFORE SIGNING.

In consideration of the Releasees acceptance of my application for entry in the above event, I hereby freely agree to and make the following contractual representations and agreements.

I acknowledge that participating in an organized cycling, running or walking event, regardless of the distance, includes an element of risk. I also acknowledge that cycling is an inherently dangerous sport and fully realize the danger of participating in a bicycle event. **I FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION IN A CYCLING, WALKING OR RUNNING EVENT INCLUDING,** by way of example, and not limitation, the following: inadequate safety equipment, **THE RELEASEES OWN NEGLIGENCE**, weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with cycling, walking or running.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively Successors) **I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE NOT TO SUE AND INDEMNIFY** the Releasees **FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES OWN NEGLIGENCE**, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event.

I agree it is my sole responsibility to be familiar with the course, the Releasees rules, and any special regulations for the event. I accept responsibility for the condition and adequacy of my equipment. I have no physical or medical condition which to my knowledge, would interfere with my ability to participate in this event or would endanger myself or others if I participate in this event. I agree that event officials may authorize necessary emergency medical treatment for me. **If I am a cyclist, I will participate wearing a helmet which satisfies the requirements of the Releasees Rules or Regulations and that can protect against serious head injury, and assume all responsibility and liability for the selection of such a helmet.**

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any other provision herein or as a consent to any subsequent waiver or modification.

I also understand and agree that any sponsor may subsequently use, for publicity or promotional purposes, my name or pictures of me participating in this event without liability or obligation due me.

Every term and provision of this agreement is Intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
